

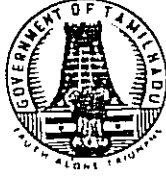

ORDER:-

In the letter first read above, the Chief Engineer (Construction & Maintenance), Highways Department has sent proposals to take up new works to the tune of Rs.4455.00 crore under Comprehensive Road Infrastructure Development Programme (CRIDP), for the year 2013-2014.

2. In the letter second read above, the Government have requested the Chief Engineer (Construction & Maintenance), Highways Department to send the revised proposal under Comprehensive Road Infrastructure Development Programme 2013-2014 to Rs.2950.00 crore.

3. In the letter third read above, the Chief Engineer (Construction & Maintenance), Highways Department has sent the revised proposals giving importance for widening of State Highways from Intermediate Lane to Double Lane and Major District Roads from Single Lane to Intermediate Lane and widening and strengthening of Other District Roads, bridges, culverts etc as announced by Hon'ble Chief Minister, at a total cost of Rs.2950.00 crore under Comprehensive Road Infrastructure Development Programme for the year 2013-14 as detailed below:

4. The Government have examined the proposal of the Chief Engineer (Construction & Maintenance), Highways Department in detail and decided to accept the same. Administrative sanction is accorded for widening and improvement of State Highways, Major District Roads, Other District Roads and bridges culverts etc. at a total cost of Rs.2950.00 crore (Rupees Two Thousand Nine hundred and Fifty crore only) under the Comprehensive Road Infrastructure Development Programme for the year 2013-2014 as per outlay indicated in Para 3 above. The details of the works are annexed to this order.

5. The expenditure sanctioned in Para 4 above shall be debited to the following heads of account:-

(i) State Highways for Rs.102126.56 lakhs (Rupees One thousand twenty one crores and twenty six lakhs and fifty six thousand only :-

5054 – Capital Outlay on Roads and Bridges – 03- State Highways – 337 – Road Works – Schemes in the Twelfth Five year Plan-II-State Plan-JI-Comprehensive Road Infrastructure Development Programme – State Highways – 16. Major works. (DP Code 5054-03-337-JI-1602)

(ii) Major District Roads for Rs.117888.44 lakhs (Rupees One thousand One hundred and Seventy eight crores and eighty eight lakhs and forty four thousands only :-

5054 - Capital Outlay on Roads and Bridges – 04 -District and Other Roads – 337- Road Works – Schemes in the Twelfth Five year Plan-II -State Plan –JT-Comprehensive Road Infrastructure Development Programme – Major District Roads – 16. Major works. (DP Code 5054-04-337-JT-1609)

(iii) Other District Roads for Rs.46789.00 lakhs (Rupees Four hundred and Sixty seven crores and eighty nine lakhs only :-

5054 - Capital Outlay on Roads and Bridges – 04- District and Other Roads-337- Road Works – Schemes in the Twelfth Five year Plan-II-State Plan –JU-

Comprehensive Road Infrastructure Development Programme – Other District Roads – 16 Major works. (DP Code 5054-04-337-JU-1607)

- (iv) Special Component Plan (Other District Roads) for Rs.28196.00 lakhs (Rupees Two hundred and eighty one crores and ninety six lakhs only :-

5054 - Capital Outlay on Roads and Bridges – 04 - District and Other Roads – 789 – Special Component Plan for Scheduled Castes – Schemes in the Twelfth Five year Plan-II-State Plan- JC Comprehensive Road Infrastructure Development Programme – Other District Roads – Under Special Component Plan – 16 Major works. (DP Code 5054-04-789-JC-1606)

6. The Chief Engineer (Construction & Maintenance), Highways Department, is directed to take up the works early and furnish monthly progress report to Government. He is also requested to ensure that the works sanctioned now are not included in any other schemes and have not been taken previously.

7. The Chief Engineer (Construction & Maintenance), Highways Department is also authorized to make changes in the nomenclature of works or delete / substitute works without exceeding the total cost of the work, subject to obtaining prior approval of the Government.

8. This order issues with the concurrence of Finance Department vide its U.O.No.2655/FS/P- 13 dated 24.07.2013.
