ORDER :-

During the Budget Session 2021-22 the Hon'ble Minister for Public works has announced the following:-

i) "important State Highways connecting District and Taluk Headquarters will be widened to 4-lane for a length of 2200 km and 6700 km will be widened to 2-lane in the next 10 years based on the traffic intensity. In this financial year 250 km length of important State Highways will be widened to 4-lane at an average cost of Rs.2000 crore and 600 km length of important State Highways will be widened to 2-lane at an average cost of Rs.1200 crore will be taken up under "Hon'ble Chief Minister's Road Development Program".

ii) "in lieu of existing 1281 Causeways, High Level Bridges will be constructed at a cost of Rs.2401 crore. Initially 648 Causeways will be taken up at a cost of Rs.609.71 crore".

iii) "road safety works for Rs.200 crore will be taken up under Comprehensive Road Infrastructure Development Programme (CRIDP)".

iv) "State Highways and Major District Roads in Corporation, Municipality and Town Panchayat will be widened to four lane with paved shoulder. If there is required land available the roads will be widened to four lane with paved shoulder and if there is no land available for four lane then the road will be widened up to Right of Way (RoW) based on traffic intensity to cater the increased traffic. In order to avoid stagnation of rain water, drains with footpath will be constructed. For this

scheme 10% of fund will be provided from Comprehensive Road Infrastructure Development Programme (i.e.) Approximately Rs.400 crore”.

v) “Cement Concrete road will be constructed in temple car riding street in Thiruvannamalai Arulmigu Arunachaleswarar Temple for an amount of Rs.15.00 Crore”.

2. Based on the above announcements and the detailed discussions held on the requirements based on site conditions the Chief Engineer (Construction and Maintenance), Highways Department in the letter third read above has sent the list of 3659 works to be taken up under Comprehensive Road Infrastructure Development Programme (CRIDP) 2021-22 for an amount of Rs.7500 crore and requested to accord Administrative Sanction.

3. The Government after careful examination of the proposal of the Chief Engineer (Construction and Maintenance), Highways Department accord administrative sanction to carry out various types of 3659 No. of works at a total cost of Rs.7500,00,00,000/- (Rupees Seven Thousand Five Hundred Crore only) under Comprehensive Road Infrastructure Development Programme (CRIDP) 2021-22 as annexed to this order. 7. Proposal for any changes in the nomenclature of works or deletion / substitution of works without exceeding the total cost of the work shall be sent to Government for necessary orders. Under any circumstances, Revised Administrative Sanction will not be entertained.
